

34th Ave S Reconstruction update

- Grading between 55th and 56th St E is completed
- Kusske construction have been working on storm and sanitary main and as well as private connection between 56th St E and 58th St E.
- Premier Electrical have been working on installing foundation for lighting unit and conduit behind curb.
- Potholing at 53rd & 54th St E intersection is completed
- Max Steiniger have been working on grading driveways between 54th and 56th St E

Anticipated work for tomorrow and next week

- **Weekend work:** -
 - **Ti-Zack**, Max Steiniger sub-contractor is planning to pour curb and gutter and also bus pad tomorrow
 - **Kusske** construction, Max Steiniger sub-contractor will keep working on sanitary main and private connection tomorrow
- **Closure:** -
 - **58th St E intersection is tentatively scheduled to be closed** for 10 days starting **Thursday June 13, 2019**. This closure is necessary in order to complete some of major construction activities at the intersection, such as remove concrete pavement and Sidewalk, install catch basins, subgrade preparation, install curb. Please understand that the construction schedules are subject to change due to weather and unforeseen circumstances.
- Drive way placement, between 54th St E and 56th St E,
- Complete storm work between 56th and 58th St E
- Finish sanitary sewer main and service work between 56th and 58th St E.
- Concrete curb & gutter placement between 54th and 56th St E
- Sidewalk grading and placement between 54th and 56th St E
- Remove driveway between 56th St E to 58th St E
- Continue working on installation of lighting conduit and foundation for lighting unit.
- Remove pavement, curb & gutter and sidewalk at 58th intersection

Please understand that the construction schedules are subject to change due to weather and unforeseen circumstances.

- CenterPoint Energy's utility contractor Michaels have finished removing abandoned gas pipe for phase I (54th St E to 58th St E)

Our construction activities are likely to cause you some inconvenience, but we are hopeful that you will be patient and understanding as the work progresses. For our part, we will do our best

Important:

- Our equipment is large and heavy and can be **extremely dangerous** if one is not alert around it. We urge you to stay at a safe distance at all times. Please, above all, impress upon your children not to go beyond the sidewalk at any time and to stay away from material piles and equipment parked on or near the job site. Please observe all posted detour routes and warning signs and arrange to park on side streets or on another block when work is under way in your immediate area.
- Help us prevent vandalism during construction. It not only delays the project but adds to the costs. Your cooperation in reporting or preventing such acts is critical and directly benefits you.
- To save yourself time and money, if you have experienced any problems with your sewer and/or water connection it is recommended that you contact a licensed plumber as soon as possible to correct the problem **before** the street is paved. One problem frequently encountered in connection with street paving is the condition and age of the private water and sewer services from the house or business to the City main in the street. Occasionally, because of the age and condition of these services, they may require repair or replacement within a relatively short period of time after the new paving is completed. So, if you are planning to upgrade your water or sewer service, please call me at 612-673-3716 to coordinate with the project's schedule.
- To install new curb and gutter and sidewalks, we will need to excavate within the City right of way. Please note that the City right of way extends beyond the back of existing sidewalks. After we complete this work we will remove our construction debris and place new topsoil and sod where it was disturbed. We plan to place sod in the fall of this year. Any private lawn sprinkler systems, decorative carriage walks, special flowers, bushes or other decorative lawn items in the City right of way are the responsibility of the property owner.
