## Qualifications & Experience Requirements

**Public Works Service Worker I Trainee**

- 18 Years of age by October 31, 2019.
- High school Diploma or GED Equivalent.
- Possess and maintain a valid Class D Driver's License, with the ability to obtain a Class B CDL with Tanker endorsement within 6 months of employment.

**Public Works Service Worker I**

- 18 Years of age by October 31, 2019.
- High school Diploma or GED Equivalent.
- Possess and maintain a valid Class B CDL with No Air Brake Restrictions
- One (1) year experience performing manual labor in a similar environment including operation of construction equipment.
