Minimum Fee - Residential & Commercial	\$ 83.50 (Includes \$1.00 State Surcharge)
Full Fixture - All Occupancies	\$40.60
Fixture Set Only - All Occupancies	\$40.60
Waste and Vent Only - All Occupancies	\$40.60
Rainwater Leader, for 10 stories or fraction thereof	\$40.60
Replacing or extending water distribution piping, each 100 lineal feet or fraction thereof	\$40.60
Alterations - each \$500 or fraction thereof	\$40.60

**Non-Heating Gas Burner Permit Fees\***

INPUT (BTU/HR)	FEE
Minimum Fee - Residential & Commercial	\$83.50 (Includes \$1.00 State Surcharge)
Not Exceeding 399,999 Btu	\$71.90
400,000 and over	\$285.30
Gas Piping Only	1.95% of the value or the minimum fee, whichever is greater

\* Where more than one gas burner is installed in a single device, they shall for the purpose of establishing fees, be considered as a single burner with fee based on combined total BTU capacity.
