



PHASE 2 ENGAGEMENT SUMMARY: COMMUNITY WORKSHOP & ONLINE SURVEY

18th Ave S & Little Earth Transportation Study | Department of Public Works | April 2022

Date of event: Saturday, February 26, 2022, 1:00-3:00PM **Location:** Cedar Field Park, 2500 Cedar Avenue S, Minneapolis

Public Works is conducting a Transportation Study for permanent changes to 18th Avenue S between 24th and 26th Streets, Ogema Pl and Stately St. The changes will be reflective of Little Earth, East Philips Neighborhood, businesses and agency needs and desires for the area. On November 18, 2021, Public Works with support from Little Earth Residents Association and the City's consultant hosted a Community Workshop as part of Round 1 engagement to gather feedback on community priorities. Using the feedback collected, the project team developed the proposed draft design concepts and cross-sections for the redesign of the streets. On February 26, 2022, the project team hosted a second Community Workshop as part of Round 2 engagement to share the proposed concepts with the community. This engagement summary documents the details and comments received during the outdoor, in-person event, as well as the outcomes of an online survey which was available to those who could not attend the in-person event.

About the community workshop

- Audience: Residents and adjacent property owners surrounding the study area (primarily from Little Earth and East Phillips neighborhoods).
- Format: To follow CDC guidelines and help prevent the spread of COVID-19; the project team held the event outdoors, encouraged social distancing, and had disposable masks and sanitizer available and encouraged attendees to follow advertised precautions.
- Presentation Boards: included background information on the study as well as four boards illustrating proposed draft design concept designs for 18th Ave S, EM Stately St and Ogema Pl.
- Activities: Warming fires and s'mores for attendees.
- Incentives: \$25 Target gift cards were awarded to the first 40 attendees/heads of households that provided feedback to the project team.

What we heard

The following comments were received during the Community Workshop where community members were asked to select the elements they liked best between the two different proposed draft concepts, as well as vote on the street elements and features they liked the best.

(24th St to 26th St)



18th Avenue South (24th St to 26th St)

- 1. Very strong support for Concept 1, Celebration Street for 18th Ave S
- 2. Most but not all support the "Y" diverter in Concept 2 for 18th Ave S
- 3. Several felt that on-street parking should be provided on the east side of 18th Ave S, south of Cedar Field Park
- 4. Support for raised crosswalk on 18th Ave S
- 5. Support for planters and landscaping, especially rain gardens and native landscaping
- 6. Support for pedestrian scale lighting







EM Stately Street

- 1. Some concern about vehicles being able to pass each other in-between bump-outs on Stately St
- 2. Strong support for increased/enhanced landscaping on Stately St
- 3. Support for pedestrian scale lighting




Ogema Place





Ogema Place

- Slightly more support for partially converting a segment of Ogema Pl as shown in Concept 1 to a greenway vs. keeping it open to vehicle traffic
- Support for greenway/art installations on Ogema Pl
- Strong support for sidewalks on both sides of Ogema Pl
- No clear preference one way or the other on the one-way paring of Stately St and Ogema Pl, however, more people indicated support for a bikeway/trail option as shown in Concept 1 vs. converting the operation of both streets to a one-way
- Very strong support for improved pedestrian-level lighting especially the incorporation of creative lighting such as string lights to provide more coverage along the street

Online Survey

In addition to the in-person Community Workshop, the project team gathered feedback on the proposed draft design concepts through an online survey via the project webpage between February and March 2022. The online survey included an informational pre-recorded video presentation from the project team which covered the background on the Transportation Study and an overview of the six draft design concepts. The survey asked participants on which design features they supported and preferred for each one of the streets within the project area.

Who We Heard From

A total of 16 participants provided feedback through the online survey. Ten survey respondents identified as Little Earth residents, four as East Phillips residents, and the rest as residents from other neighborhoods in Minneapolis.






What We Heard – Top Themes

The following is a summary of the top themes we heard about each draft design concept.

18th Avenue S Concept 1 – One-Way Celebration Street

- Approximately half of the respondents mentioned they would support enhanced lighting, raised crossings, and a one-way celebration street on Concept 1.
- A couple of participants also commented that parking on both sides of 18th Avenue S should remain.


What features of 18th Ave S Concept 1 would you support? (Select top 3)



18th Avenue S Concept 2 - One-Way Green Street

- Nine out of fourteen respondents (64%) selected raised crossing as a feature they would support on Concept 2. Half of the participants responded they would support enhanced lighting.
- A couple of participants also shared concerns about the installation of a Y-diverter at the 18th Avenue and 25th Street intersection.

What features of 18th Ave S Concept 2 would you support? (Select top 3)








EM Stately Street - Narrower Street with Bump-Outs

- Most respondents (86%) answered they would support enhanced lighting on EM Stately Street.
- Eight out of fourteen participants (57%) responded they would support bump-outs to slow traffic, as well as enhanced landscaping.


What features of the EM Stately Concept would you support? (Select top 3)



Ogema Place Concept 1 – Celebration Street with Greenway

• Ten out of fourteen respondents (71%) mentioned they would support pedestrian lighting. Six participants (43%) also responded they would support overhead string lighting along Ogema Place.


What features of the Ogema Place Concept 1 would you support? (Select top 3)

• The top features selected by respondents were new sidewalks along gardens (62%), enhanced lighting (54%), and raised crossings (46%).

What features of the Ogema Place Concept 2 would you support? (Select top 3)








Ogema Place Concept 2 – Narrower Street

• The top features selected by respondents were new sidewalks along gardens (62%), enhanced lighting (54%), and raised crossings (46%).

EM Stately Street and Ogema Place – One-Way Streets

- A majority of participants (77%) selected enhanced lighting as a feature they would support as part of the one-way streets concept.
- Eight out of thirteen respondents (62%) mentioned they would support new sidewalks along gardens.
- Almost half of the respondents (46%) selected the one-way street concept as a top feature they could support.





Next Steps & Timeline

Based on the key themes heard on the proposed draft design concepts, the project team will finalize the preferred design concepts, which will be shared back with the community. Following the completion of the preferred design concepts, Public Works will move forward with completing the Transportation Study and pursuing funding to implement the proposed designs.
