## License Application Guidelines and Checklist

### **License Type: Peddler**

**Definition:** A person who offers merchandise or services for sale door-to-door, including house-to house, business-to-business, street-to-street, or any other type of place-to-place movement. Delivery and payment occur immediately. An application for a city license to conduct business as a peddler or transient merchant shall be made at least fourteen (14) regular business days before the applicant desires to begin conducting a business operation within the city.

#### Similar Licenses:

**Non-Commercial Advocate:** A person who disseminates religious, political, social, or other ideological beliefs. No registration, license, or identification card is required.

Solicitor: A person who obtains orders for merchandise or services for future delivery. Registration required. No fee.

**Transient Merchant:** A person who temporarily sets up business out of a vehicle, trailer, boxcar, tent, other portable shelter, or empty store front for the purpose of selling goods. Individuals may not remain in one location for more than 14 consecutive days. Delivery and payment occur immediately.

**Youth Fundraiser:** A person, age 17 and under, selling merchandise or services or seeking donations on behalf of a school, church, sports or scouting organization. One registration is required per group and individuals must display a city approved identification badge. No fee.

#### 2. Identification Cards

Each peddler, solicitor and transient merchant will be issued an identification card from the division of Licenses and Consumer Services which expires on June 30<sup>th</sup> each year unless otherwise indicated on your identification badge. You are required to display your identification card at all times while engaged in solicitation and present upon request.
