Phillips Traffic Safety Improvements: Phase 1 Community Comments




We are responding to your feedback!

The community shared 351 transportation safety concerns & comments as part of the Phillips Traffic Safety Project Phase 1 community engagement, which took place in the summer/fall of 2021.

164 comments are tied to a location and shown as exclamation marks on the map. Information was collected at community events, through online surveys, and at in person and online meetings.

The symbol size indicates the relative amount of comments received for each location. Several Streets with high number of comments (Cedar Ave, Park Ave, and Portland Ave) are managed by Hennepin County. Minneapolis Public Works has shared these comments with the County.





Funding Opportunities


Phase 1 community engagement is also helping secure critical regional funds for safety improvements in the Phillips neighborhood.
