# The Advocates for Human Rights

At the forefront of the world's human rights movement, The Advocates for Human Rights, a volunteer-based organization, implements human rights standards to promote civil society and reinforce the rule of law. The organization creates and maintains sustainable, comprehensive, and holistic change on a local, national, and global scale.

For more than 30 years, The Advocates' innovative programming has changed the lives of refugees and immigrants, women, ethnic and religious minorities, children, and other marginalized communities. The organization investigates and exposes human rights violations; represents people who are seeking asylum; trains and assists groups that protect human rights; engages the public, policy-makers, and children; pushes for legal reform; and advocates for sound policy.



# Refugee & Immigrant Rights

The Advocates represents refugees and immigrants, advocates for legal reform, and works to help better integrate our newest residents into communities. It is the largest provider in the Upper Midwest of free legal services to low-income asylum seekers, refugees, and immigrants.

Asylum is a legal protection and immigration status for people who are in the United States and afraid to return to their home country because of fear of persecution on account of their race, religion, nationality, political opinion, or membership in a particular social group. # Women's Human Rights

The Advocates' Women's Human Rights Program works tirelessly to make a better, safer world for women. Expert staff and volunteers help draft laws promoting women's safety and provide commentary on countries' new and proposed domestic violence laws. The Advocates publishes reports on violence against women, working with global partners to document women's human rights violations. It trains police, prosecutors, lawyers, and judges, in collaboration with host country partners, to implement both new and existing domestic violence laws.

## Advocacy

The Advocates uses advocacy to protect the human rights of asylum seekers, refugees and immigrants, and women and girls; support human rights defenders; and work towards abolishing the death penalty. To acheive its advocacy goals, The Advocates uses international human rights mechanisms; works legislatively in Minnesota, the United States, and partner countries; participates legally; and is active in local, national, and international coalitions.

### International Justice

The Advocates develops innovative, sustainable strategies to hold governments accountable for human rights abuses and to strengthen institutions in the international justice system. The Advocates holds Special Consultative Status with the UN, and it also participates in regional human rights mechanisms, such as the African Commission on Human and People's Rights.

At the UN, The Advocates presents oral and written statements to charter-based bodies, such as the Human Rights Council. It participates in UN review of compliance with human rights treaties through shadow reporting and provides expert technical advice.

The Advocates develops practical strategies and tactics to assist disapora communities to promote change in their home countries, and assists post-conflict countries to move toward peace and accountability.

# Human Rights Education

Education is one of the best ways to ensure longterm improvements in respect for human rights everywhere. The Advocates develop educational tools to help people learn and apply international human rights standards in their families, schools, workplaces, and communities.
