

Minnesota Traffic Safety Camera Citation

Minnesota Statutes Tshooj 169.147 tso cai rau ib lub nroog koom nrog hauv Kev Ruaj Ntseg Tshab Khiav. Raws li tau teev hauv tshooj no, tus thawj saib xyuas cov kev khaiv oom tes nrog tus thawj ntawm kev nyab xeeb ntawm cov pej xeeb yuav tsum tsim ib qhov kev sim siv koob yees duab rau kev ruaj ntseg ntawm kev tshab khiav kev qhia thiab kev siv cai rau kev txhaum kev khiav ceev dhau cai raws li Minn. Stat. §169.14, subd. 13, kev txhaum tswj teeb liab ntawm kev tshab khiav raws li Minn. Stat. §169.06, subd. 10, los yog ob yam ntawd ua ke nrog kev sim siv koob yees duab. Daim duab uas luam tawm ntawm nplooj ntawv no yog pov thawj tias muaj kev txhaum ib qho ntawm Minn. Stat. §169.14, subd. 13, los yog §169.06, subd. 10.

Tus tswv lossis tus xauj ntawm lub tshab tsis raug nplua lossis txiav txim raws tshooj 169.06, subdivision 10 yog tias:

- (1) lub tshab tau raug nyiaj thaum lub sijhawm ua txhaum;
- (2) kev hloov tus tswv ntawm lub tshab uas ua raws tshooj 168A.10 twb tau ua ua ntej lub sijhawm ua txhaum;
- (3) tus tswv tshab yog tus xauj tshab ntawm lub tshab, thiab tus xauj qhia lub npe thiab chaw nyob ntawm tus xauj tshab;
- (4) lub tshab yog ib lub tshab raws kev cai siv rau xwm ceev uas khiav haujlwm ntawm nws txoj haujlwm nom tswv thaum lub sijhawm ua txhaum;
- (5) lwm tus neeg raug txim, raws li txhais hauv tshooj 171.01, subdivision 29, rau tib qhov kev txhaum ntawd;
- (6) tus tswv tshab tsa tes cog lus rau lub tsev hais plaub lossis tus coj plaub lus tias tus tswv tsis tau tsav lub tshab thaum lub sijhawm ua txhaum;
- (7) tus tswv tshab tsa tes cog lus rau lub tsev hais plaub lossis tus coj plaub lus tias tus tswv yog tus tsav lub tshab thaum lub sijhawm ua txhaum vim muaj kev kub ntshov kho mob rau tus tsav tshab lossis tus caij tshab nyob hauv lub tshab; los yog
- (8) tus tswv lossis tus xauj ntawm lub tshab tau txais lwm daim citation rau tib qho kev coj ua ntawd.

Tshwj tsis yog thaum kev ua txhaum tshwm sim hauv ib lub tshab lag luam, lossis thaum kev ua txhaum ntawd yog ua los ntawm tus tuav class A, B, lossis C commercial daim ntawv tsav lossis commercial daim ntawv kawm tsav:

Tus neeg uas ua kev ua txhaum thawj zaug yuav tsum tau txais kev ceeb toom thiab tsis raug nplua lossis raug txim. Tus neeg uas ua kev ua txhaum zaum ob muaj cai mus koom kev hloov kev coj uas yuav tsum muaj kev kawm txog kev ruaj ntseg tshab khiav uas tau tsim raws tshooj 169.147, subdivision 11. Tus neeg uas tau koom kev hloov kev coj thiab ua tiav kev kawm kev ruaj ntseg tshab khiav yuav tsis raug nplua lossis raug txim.

Yog muaj kev txiav txim tiav lawm, kev txiav txim ntawd tsis yog ib qho laj-thawj uas yuav ua rau tshem lossis yus daim ntawv tsav tshab.

Thaum kev ua txhaum tshwm sim hauv commercial motor vehicle, lossis kev ua txhaum yog ua los ntawm tus tuav class A, B, lossis C commercial daim ntawv tsav tshab lossis commercial daim ntawv kawm tsav, ob npe lus saum toj no tsis siv.

RAU KEV PAUB TXOG: Tag nrho lossis ib feem ntawm tus nqi ntawm daim ntawv xaj kom tuaj yuav raug tshem tawm yog tias muaj pov thawj tias koj lossis koj tsev neeg muaj kev txom nyem nyiaj txiag lossis kev nyuaj siab nyiaj txiag loj heev. Koj tuaj yeem teem sijhawm kev tshwm sim hauv tsev hais plaub los thov kom tshem tus nqi ntawd raws li koj lub peev xwm them tau los ntawm kev hu rau Minnesota Court Payment Center (CPC). Yog koj siv xov tooj hauv thaj tsam metro area (612, 651, 763, lossis 952) los yog xov tooj txawv teb chaws, hu rau 651-281-3219; rau lwm tus hu rau 1-800-657-3611. Rau cov lus qhia ntiv, hu rau CPC lossis mus saib www.mncourts.gov/fines.

THOV SAIB daim ntawv QHIA TXOG TXHUAM YAM uas muab nrog daim citation no uas muaj cov lus qhia ntiv txog yuav teb li cas lossis yuav tawm tsam daim citation no li cas.

Tej zaum yuav siv sijhawm txog 7 hnub txij hnub koj tau txais daim citation kom CPC ua tiav cov ntaub ntawv ua ntej lawv thiab li pab tau koj lossis kom koj them tau koj cov nplua online.

Mus rau www.mncourts.gov/fines kom paub seb koj daim citation puas them tau yam tsis tas mus rau tsev hais plaub, npaum li cas them, yuav teem sijhawm mus li cas, yuav thov kev them nyiaj raws kev npaj li cas, thiab lwm yam ntaub ntawv tseem ceeb.

YUAV THEM KOJ DAIM CITATION, xaiv ib qho ntawm cov kev no:

- **Online:** Mus rau www.mncourts.gov/fines. Muaj koj daim citation lossis case nab npawb npaj txhij. Yuav muaj kev them nyiaj ntiv rau nqi tes.
- **Xov Tooj:** Hu rau CPC. Muaj koj daim citation lossis case nab npawb npaj txhij. Yuav muaj kev them nyiaj ntiv rau nqi tes.
- **Xa Ntawv:** Sau Tshab lossis Money Order them rau Court Administration, Minnesota Court Payment Center, P.O. Box 898, Willmar, MN 56201. Ntiv daim citation luam lossis sau citation nab npawb rau ntawm daim tshab lossis money order.
- **Tus Kheej Tuaj Mus:** Koj tsuas tuaj them rau hauv lub county uas teev nyob saum koj daim citation hauv qhov chaw hu ua "Lub Nroog Lub Npe." Cov chaw hais plaub muaj nyob ntawm www.mncourts.gov/Find-Courts.aspx.

KOJ MUAJ CAI MUS RAU TSEV HAIS PLAUB. Koj yuav tsum them tus nqi uas koj raug them **LOS YOG** teem sijhawm mus hais plaub hauv 30 hnub txij hnub uas daim citation no tau xa mus rau lub tsev hais plaub. Rau cov lus qhia ntiv txog yuav them li cas, yuav teem sijhawm hais plaub li cas, lossis lwm yam ntaub ntawv tseem ceeb, hu rau CPC ntawm tus xov tooj saum toj no los yog mus rau www.mncourts.gov/fines.

YOG KOJ THEM COV NPLUA, koj tab tom lees tias koj txhaum rau qhov kev ua txhaum no thiab kam tso tseg koj cov cai raws li hauv qab no: (Minn. R. Crim. P. 23.03)

1. Txog kev hais plaub, yog tias qhov kev ua txhaum yog me nruab nrab, los yog kev sim plaub hauv tsev hais plaub lossis nrog pawg neeg txiav txim rau lwm yam kev ua txhaum;
2. Txog kev muaj tus lij choj sawv cev;
3. Txog kev raug suav tias tsis txhaum kom txog thaum raug pov thawj tias txhaum dhau qhov kev ntseeg tau;
4. Txog kev ntsib thiab nug txhua tus tim khawv; thiab
5. Txog kev nyob twjywm lossis qhia ntawm koj tus kheej.

YOG KOJ TSIS THEM LOS YOG TSIS MUS RAU TSEV HAIS PLAUB:

- Tej nqi nplua thaum them lig yuav raug nqi ntiv.
- **Kev tsis tshwm tuaj hais yuav raug suav tias yog kev lees txhaum** thiab tshem koj cov cai, suav nrog cai sim plaub, rau qee hom kev ua txhaum, tshwj tsis yog koj tshwm sim hauv tsev hais plaub tsis pub dhau 10 hnub tom qab hnub uas koj tsis them lossis tsis tshwm thiab qhia tias qhov ntawd yog vim teeb meem uas tsis nyob hauv koj kev tswj. (Minn. Stat. §169.91; §609.491; Minn. R. Crim. P. 23.04–23.05)
- **Daim ntawv ntes yuav raug tso tawm rau koj.**

Yog tias koj tsis yog pej xeeb Asmeskas, kev lees txhaum yuav ua rau poob cai nyob hauv teb chaws, tsis pub rov tuaj, lossis tsis pub txais ua pej xeeb (Minn. R. Crim. P. 15.02, subd. 1(3))

Kev lees txhaum yuav raug teev tseg.

Lub Department of Public Safety yuav raug ceeb toom txog koj kev tsis them lossis tsis tshwm, thiab/los yog kev raug txim, thiab tej zaum yuav yus lossis tshem koj daim ntawv tsav tshab, nyob ntawm qhov xwm txheej ntawm koj rooj plaub.

Raws li tshooj Minn. Stat. §480.15, subd. 10c, yog koj tsis them koj cov nqi nplua raws sijhawm, tej zaum yuav raug xa mus rau qhov kev sau nyiaj. Koj muaj cai tawm tsam qhov kev xa ntawd yog tias koj tsis muaj peev xwm them.

Kev sau daim tshab tsis muaj nyiaj rau lub tsev hais plaub yog kev ua txhaum cai, thiab koj yuav raug nplua thiab raug ntes raws cov kev cai lij choj. Ntiv rau qhov ntawd, nqi txog \$30 yuav raug ntiv rau txhua daim tshab uas raug thim rov qab (Minn. Stat. §604.113, subd. 2).
