



# Ward 2 Survey Responses

From Office of Ward 2 Council Member Robin Wonsley

As an independent Democratic Socialist, Council Member Wonsley is committed to bringing working class people into the center of local politics. The Ward 2 office strives to find new ways to reach residents and invite them to be involved. We value and work closely with residents and organizations who are already organized and engaging with local civic matters, and simultaneously try to reach people who are not already engaged, who are often younger and disproportionately renters and residents of color.

In May, the Ward 2 Office published a survey for all Ward 2 residents asking their opinions on a broad range of political priorities. The survey was published online in English and Somali, and publicized through traditional channels like our Ward 2 social media and email, through neighborhood associations, unions, and community organizations. We took the additional step of sending a piece of mail to all the residential addresses in Ward 2 (over 33,000 residents at roughly 11,000 addresses) inviting them to take the survey and attend a virtual or in-person community conversation about the topics it covered.

The survey was an experiment in a new method of constituent engagement. We worked with city's experts in data management, IT, and Neighborhood and Community Relation to develop a tool that we thought might help advance our goal of bringing more people into the political process.

We had no idea how well the survey would work. Now, we can identify what worked and what can be improved, as well as use the aggregated responses as data points in ongoing political work.

Key successes of the survey include nearly 1,000 residents participating, about 3% of the entire Ward. This is particularly notable since the survey was open from May to August when college students, who are a significant percentage of the Ward 2 population, are out of town. Based on rates of constituent engagement with our office, we are confident that the survey was successful in expanding the number of individuals who directly communicated political opinions and priorities with our office. The survey was a great tool for tabling at community events. We had over 20 respondents who completed the survey at the Como Sustainable Living Fair or Open Streets Franklin, many of whom were young residents who were not actively engaged with local government.

We can also identify some ways that the survey was not successful. While we are confident that we engaged a number of residents who would not ordinarily have participated, 3% participation is still far from our goal of mass community engagement. The self-reported demographic data indicates that the respondents still skew older and were more likely to be homeowners than Ward 2 as a whole. It also skewed heavily towards the south of the Ward. In order to make the survey a low-barrier activity for Ward 2 residents and remain in compliance with Government Data Practices, the survey was completely anonymous and did not require any verification that the respondent actually lives in Ward 2. This means that we have no idea what percentage of respondents are residents and what percentage, if any, are not Ward 2 residents.

Based on these observations, we are working to strengthen future community engagement work. We are going to do a Student Survey in September so that as students return to campus, their opinions are collected and integrated into our overall understanding of the Ward. We are planning to include a checkbox attesting to Ward 2 residency at the beginning of future engagement activities as a way to better filter participation to better represent those who live in the Ward. These are just some of many takeaways that we have learned through the survey process. It is exciting and meaningful for the Ward 2 Office to sharpen the ways we gauge resident priorities and support their needs.

Due to the challenges described above, the results of the survey should be understood as one data point amongst many rather than firm conclusions. We hope they can be useful contributions to ongoing discussions about a broad range of political topics, as well as contributing to the shared goal of engaging more working-class residents into the political conversations happening citywide.

### Survey Administration

- Sent via US mail to all 11,441 mailing addresses in Ward 2, excluding dorms. Approximately 2,000 were unable to be delivered due to empty residence.
- Additionally publicized via Ward 2 email list social media, neighborhood associations, community groups, unions, and community events.
- Language options in English and Somali.
- Instructions included that the survey should only be completed by Ward 2 residents, but no other form of evidence or attestation was required.
- We collected 950 responses between May 5th and August 18.
- All questions were optional, including demographics.
- We are conducting a separate survey for students starting in September.

### Demographics

- All demographic questions were optional.
- For Neighborhood, Housing, Age, and Student Status, respondents could select only one option. For Race & Ethnicity and Gender, respondents could select multiple options, and/or select “Other” and write their own answer.
- Demographic data is not systematically collected by Ward. For purposes of comparing respondent demographics with the Ward 2 population, we used a [Custom Geography on the Minnesota Compass](#) which roughly approximates the Ward based on the census tracts that most closely match the Ward boundaries. Because this is the closest available approximation of Ward 2 demographics, we refer to it as a point of comparison.

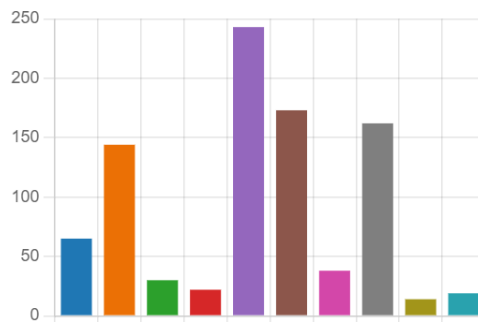

- 17% of respondents live in Seward. 18% of Ward 2 residents live in Seward.
- 21% of respondents live in Prospect Park or East River Road. 28% of Ward 2 residents live in Prospect Park-East River Road.
- 11% of respondents live in East Bank, West Bank, Stadium Village, or Riverside. 17% of Ward 2 residents live in the University of Minnesota Neighborhood, the closest geographic approximation of those areas.

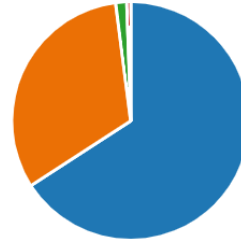

- 33% of respondents rent. 57% of Ward 2 residents are renters.

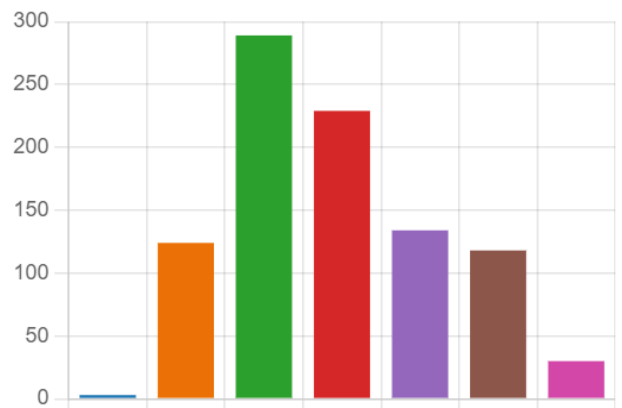

- 3% of respondents are aged 75+. 3% of Ward 2 residents are aged 75+.

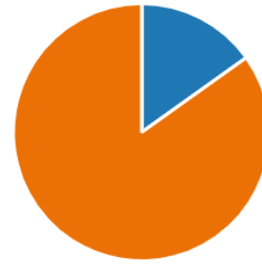

- 15% of respondents are students. There is not demographic data available about student status.

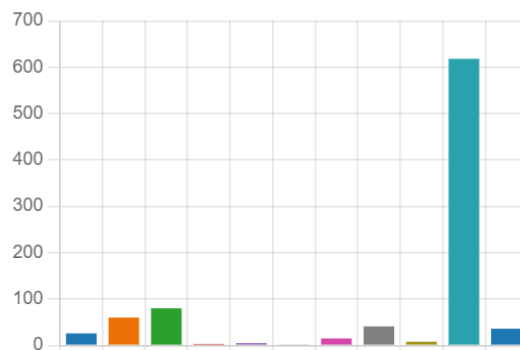
