ENGAGEMENT PLAN

West Fulton Neighborhood Improvement Project



Project background

The West Fulton Neighborhood Improvement project will make street improvements to the Fulton neighborhood from France Ave S to Xerxes Ave S, and from 47th St W to 54 St W. The streets in this area will be evaluated for improvements to repair deteriorating pavement, upgraded pedestrian ramps, All Ages and Abilities bike improvements, and incorporating green storm water infrastructure. The focus will be on improving street conditions for people of all ages and abilities. The project will consider various traffic calming measures to achieve this goal.

LOCATION

Southwest Minneapolis near Pershing Field Park, Southwest High School, and Minnehaha Creek.

TRAFFIC SAFETY

Uses traffic calming street treatments to improve safety for all users.

Y SUSTAINABILITY

Installing green stormwater infrastructure like rain gardens in the curb to support a

sustainable city.

NETWORKS

Portions of the project area are designated as near-term low stress bikeways on the AAA bicycle network.

Community analysis

COMMUNITIES OF IMPACT

The project neighborhoods have, according to 2020 American Community Survey 5-year Estimates:

 A higher portion of people ages 65 and older (15.4%) than Minneapolis as a whole (6.9%).

DEMOGRAPHIC SUMMARY

- All segments of the project area fall in TEP Tier 5.
- A lower portion of residents of color (13%) compared to Minneapolis as a whole (37.3%). This can indicate the possibility of existing racial covenants (learn more about the <u>Just Deeds</u> project).
- A lower proportion of residents indicate they have a disability (5.7%) compared to Minneapolis as a whole (11.2%).
- A lower proportion of residents are renters (10%) than in Minneapolis as a whole (48.4%).

Fall-Winter 2024: Public Works will collect project area data and initiate a community engagement process.

2025: Construction begins with pedestrian curb ramp upgrades in areas south of 50th St. in 2025 and is phased over the next several years.
