I/We are applying for the following opportunities (See pages X and X of the Call for Artists):

☐ Humboldt at 41st - \$110,000

An offset intersection between two residential neighborhood streets. The project will add a diverter to prevent cars driving through. It will add green space and a trail in the middle of the intersection.

☐ Folwell Park (Near Irving Ave N at 36th Ave N) - \$110,000

At the south end of Folwell Park, the Northside Greenway will follow the existing park trails. It will cross 36th Avenue North and continue south on Irving Avenue on blocks shared with cars. The art could be in or near the park.

☐ Jordan Park (Near 29th Ave N at Irving Ave N) - \$110,000

At the south end of Jordan Park, the Northside Greenway will follow the existing park trails. It will cross 29th Avenue North and continue south on Irving Avenue N as a trail. The art could be in or near the park.

☐ 4th Ave/Humboldt at Van White Memorial Boulevard- \$110,000

The Northside Greenway trail will follow Humboldt Avenue N as it curves and becomes 4th Avenue N. It will then cross Girard Terrace/Girard Avenue N and end at Van White Memorial Boulevard. There it meets up with another trail. The art could be in or near the green space between the paths. This location is near picnic tables and a pond.

☐ Glen Gale Park (Near Irving Ave N at 23rd Ave N) - \$55,000

At the south end of Glen Gale Park, the Northside Greenway will add a new trail on the west segment of Irving Avenue. It will add green space at the angled intersection and continue south on Irving Avenue as a trail. The art could be in or near the park.

☐ Lovell Square Park (Near Irving Ave N at Oak Park Ave N) - \$55,000

At the south end of Lovell Square Park, the Northside Greenway will add a new trail on Irving Avenue. It will add green space at the intersection and continue south on Irving Avenue as a trail. The art could be in or near the park.
