Subject: City of Minneapolis Ordinance No. 2025-062

Pursuant to Minneapolis Code of Ordinances § 171.80 – Fees for Use of City Resources in Outside Work, please find below the Police Department’s report to the City Council and the Mayor regarding the use of city facilities or equipment in the performance of outside work during Quarter 1 – 2026. This report will also be published on the Department’s website in accordance with the ordinance. Please note the Department’s initial report included January 2026 data; this report includes January 2026 as part of the Q1-2026 report.

171.80 – Fees for use of city resources in outside work. “No later than one (1) month after the effective date of this section, and quarterly thereafter, the police department shall submit to the city council and the mayor, and publish on the department’s website in a format accessible pursuant to the City’s language access plan, a report of the following with respect to the use of city facilities or equipment in the performance of outside work during the prior reporting period.”
